Releaser understands and acknowledges that the activity of ice and/or snow carving has inherent dangers that cannot be eliminated, and that there may be other risks not known or reasonably foreseeable at this time. Releaser acknowledges and fully understands that social and economic losses may result from Releaser's, and/or other's actions, inactions or negligence, notwithstanding the rules of play or the condition of the premises and any equipment used.

Releaser assumes all risk of personal injury, bodily injury, permanent disability or death sustained while participating in the ice and snow carving competition including the risk of passive or active negligence of the Releaser or any other participant.
