- The parade begins at 11AM sharp. Any entrant not in their assigned spot by 10:45AM may be excluded. Entrants will be assigned a spot prior to the parade and maybe re-assigned the day of. However, this DOES NOT mean that you may choose your own spot.
- Any individual who operates a moving vehicle during the parade must possess a valid driver's license and must be over the age of 18.
- Any misconduct during line up shall result in your entry not participating in the parade. There will be no fighting amongst entries over any subject matter. Volunteers must be treated with respect.
- Signs, banners, and handouts are encouraged but must be approved by DSB staff and the current Board President. Any promotional materials not approved by those stated above will need to be removed prior to the parade's start.

All Destination Sturgeon Bay parades are G-Rated for all ages. No obscene language, provocative behavior, or potentially disruptive demonstrations will be tolerated.

If Destination Sturgeon Bay receives more than 3 complaints towards any parade entry, they have the right to remove them from future parades.
